Case Law

ROBERT W. HILBORN et al v. METROPOLITAN Court denies a motion to dismiss a claim of misrepresentation since Metropolitan arques:

(1) Robert Hilborn testified that he assisted in the creation of the inventory for the personal items lost; (2) Robert Hilborn testified that he believed that he reviewed the inventory prior to its submission to Metropolitan; and (3) there were a number of items claimed on the loss inventory form that were not found in the remains of the house, as well a lawn mower which was claimed as a loss but that the investigators found undamaged. These allegations, if true, implicate Mr. Hilborn in the alleged fraudulent misrepresentations.
